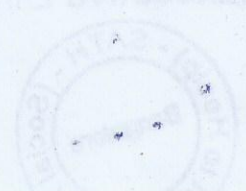

2. AIMS AND OBJECTIVES

The objectives of the Trust for which the Trust is established are:

1. To implement various slum, rural, tribal and urban development programmers for truly sustainable development of people and environment.

4. To plan and organize Health/medical camps, awareness on health, survey and research on diseases. To set up primary health units and hospitals if necessary.
5. To contact and organize children on the streets, child laborers, youth and other marginalized groups, economically, Social and culturally marginalized people part of India.
6. To plan and implement various welfare, cultural, social and economic program and events, for the upliftment and benefit of the people.
7. To provide counseling, guidance and referral services for such children, youth, women and their families and set up the infrastructure for such services and activities.
8. To establish and operate youth centers, free hostels, night shelters, training and Educational Institutions for the development of youth and children. And marginalized sections of the society.
9. To arrange and organize for cultural exchange, promote dance, drama, Environmental issues and programs such as fashion for development, micro credit for village and tribal folks, fishers, cattle, agriculture and other economically programs for sustainable development.
10. To plan and organize employment training and employment generation program in service and skill up-gradation programs and the necessary physical and financial infrastructures. And such institution to be able to issue certificates for technical and non-technical skills.
11. To work towards ameliorating the situation of such youth and to work towards better labour legislation and stringent enforcement aimed at the welfare and development of the youth: especially the child labourers and youngster employed in unorganized sector.
12. To collaborate with governmental and non-governmental agencies and individuals to ensure the welfare of such youngsters.
13. To collaborate with governmental and non-governmental agencies and individuals to ensure corruption-free delivery of service/work.






3. TRUST FUND AND PROPERTY

The sum of Rs. 2,000/- (Rupees Two Thousand Only) hereinafter called the Trust Fund is Collected as the nucleus of TRUST FUND to carry out the aims and objects of the TRUST Funds will be raised by accepting donations, conducting various types of events, freewill offering, Endowments, gifts or contributions in India and abroad in cash or kind, properties movable foundations, bequests, from any person or persons, establishments, organizations, Institutions and Governments etc. for the furtherance of the aims and objects of the TRUST and upon such terms and conditions as Trust may in its absolute discretion, decide.

AND WHEREAS for the better and more effectual HOLDING, USING and ADMINISTERING of the TRUST PROPERTY and such other funds and/ property as may be entrusted to the TRUSTEES or any successors of them in pursuance of these presents it is RESOLVED TO MAKE A DECLARATION OF TRUST concerning the TRUST FUND appoint TRUSTEES and delegate POWERS for the HOLDING USING AND ADMINISTERING of the TRUST PROPERTY and such other assets and may be entrusted to the TRUSTEES or their successors in pursuance in pursuance of these presents.

NOW THIS DEED WITNESSES that in consideration of these presents the TRUSTEES of the TRUST PROPERTY to HAVE, HOLD AND ADMINISTER the same for the TRUST PURPOSES hereinbefore recited in accordance with the POWERS hereinafter contained.

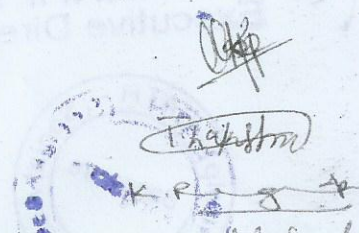
4. POWER

In pursuance of the foregoing objects (but not further or otherwise) the TRUSTEES are hereby EMPOWERED.

- A: To purchase, take on lease or in exchange, hire or otherwise acquire any property in future, real or personal, immovable or movable and any rights or privileges necessary for the promotion of the objects of the TRUST and to construct, alter, improve and maintain any buildings or erections or other property necessary for the work of the TRUST.
- B. To sell, let, mortgage, dispose of or turn to account all or any the properties or assets of the TRUST.
- C. To borrow or raise or secure payment of money in such manner as the TRUST may think fit and to secure the same or the repayment or performance of any debt, liability or contract, guarantee other engagement incurred or to be entered into by the TRUST in any way.




- D. To permit any agents or any other persons authorized by the TRUST to use and occupy any building, erections or other property of the trust on such terms and conditions as the Trust may deem fit.
- E. To enter into any arrangement with any Government or authority Central, State, Municipal or otherwise in pursuance of the objects of the TRUST and to obtain from any such Government or authority all rights concession and privileges which may seem conducive to the TRUST'S objects or any of them.
- F. To undertake and execute charitable Trusts.
- G. To receive and take any gift or money or other property for any of the objects of the TRUST and whether subject to any special Trust or not but so that the TRUST may nevertheless decline to accept any gift or take over any property having annexed to it any condition or obligation not approved by the TRUST.
- H. The funds of the TRUST shall be invested in the modes specified under the provisions of Sec. 13 (1) (d) read with section 11(5) of the Income-tax, Act, 1961.
- I. To employ all such officers and servants as may be required for the purpose of the TRUST.
- J. To act as agents any person, society or undertaking in any matter and in any lawful manner for the furtherance of the above objects of the TRUST.
- K. To open branches of the TRUST at any place in India.
- L. The board of trustees shall lay down General policy for furtherance of the aims and objects of the Trust.
- M. The Board of Trustees shall appoint standing committees or sub-committees for any General or special purposes for the efficient running of the Trust.
- N. To do all such other things as are necessary for the attainment of the above objects or any of them.
- O. The funds and the income of the Trust shall be solely utilized towards the achievement of the objects and no portion of it shall be utilized for payment to Trustees by way of profit, interest, dividends etc.
- P. The trust formed is irrevocable.
- Q. The benefit of the Trust shall be open to all irrespective of caste, creed or religion.
- R. Trust don't property any immovable property as present.

5. MANAGEMENT

The management of the Trust shall vest with the Board of Trustees which shall comprise of not more than Eleven Trustees.

6. THE TRUST

THE TRUST PROPERTY is to be used for the furtherance of the activities as aforementioned and for such other similar activities as majority of the TRUSTEES or their successors shall at any time determine.

7. THE TRUSTEES

Mr.Channappa Heera. And Miss. Lakshmi Devi.T.Shall be the Trustees and Life President/Executive Director and Life Secretary respectively for life. All other Trustees shall hold office for a term of Two years and eligible for re-election.

The number of TRUSTEES of the said TRUST shall not at any time be less than Two and when they are only Two trustees additional TRUSTEES shall forthwith be appointed PROVIDED nevertheless that the number of TRUSTEES shall not at any time exceed ELEVEN. Trustees of this shall consist of founder Trustees as well as the Trustees appointed in pursuance of this Deed. All Trustees appointed under this clause shall act in the execution of the Trust and power of this Deed together with the Trustees named in this Deed.

8. ANY of the TRUSTEES may retire from the TRUST hereof by notifying his/her fellow TRUSTEES in writing of his/her intention so to do, and from the date of receipt of such notification, the retiring TRUSTEE shall be discharged from the TRUST hereof.

9. If any one Trustees dies or becomes bankrupt, insolvent or mentally incapacitated or in the judgment or majority of the other TRUSTEES signifies by them in writing under their respective hands conducts himself in a manner unbecoming of a TRUSTEE such TRUSTEE shall cease to be a TRUSTEE OF THIS TRUST.

10. No person shall be appointed as TRUSTEE who under the preceding clause would be lawfully unable to continue to be a TRUSTEE.

11. CHAIRMAN/CHAIRPERSON

He/She shall be elected by the General Body of the Trustees and shall preside over all the meeting of the TRUST.

12. EXECUTIVE DIRECTOR

Mr. Channappa Heera President shall be the EXECUTIVE DIRECTOR for life. He shall arrange for the proceeding of all the meeting of the TRUST. He shall arrange for the carrying out of the instructions given at such meeting and attend to all statutory requirements imposed on the TRUST. He shall convene the meetings of the TRUST in consultation with the CHAIRMAN/CHAIRPERSON.

The EXECUTIVEDIRECTOR will have such powers as may be provided in the regulation to be framed from the day management of the Trust. The EXECUTIVE DIRECTOR shall at all times during the period of office as such devote full attention to the various activities of the Trust and employ faithfully and diligently and carry out all necessary steps to ensure the advantage and efficient management of the Trust. The EXECUTIVE DIRECTOR shall for services rendered be entitled to get Honorarium and other perquisites as may be decided upon by the Trustees from time to time.

13. SECRETARY

Miss. Lakshmi Devi shall be the Trustee for life. And he shall be holding the office of SECRETARY/ AUTHER OF TRUSTE. The SECRETARY/ AUTHER OF TRUSTE shall for services rendered be entitled to get Honorarium and other perquisites as may be decided upon by the Trustees from time to time.

14. THE TREASURER

He shall be responsible for the maintenance of accounts and finance of the TRUST and shall present the audited statement of accounts to the General Body of the Trustees.

15. BANK ACCOUNTS

Bank accounts of the TRUST shall be opened in the name of the TRUST.

16. THE ACCOUNTS

There shall be maintained accounts of the TRUST regularly. A Chartered Accountant shall audit the accounts every year. Accounts shall be closed every year by 31st March.

17. MEETINGS OF THE TRUSTEES

MEETINGS OF THE Trustees shall be called by the EXECUTIVE DIRECTOR when the affairs of the TRUST so demand but at least once in every year, such annual meetings being known as the ANNUAL GENERAL MEETING of the TRUST or whensoever a meeting is requisitioned by FIVE of the TRUSTEES for the time being. TWENTY ONE days notice shall be given to all meetings and a detailed agenda of the business to be transacted at all meetings shall accompany these respective notices calling the EXECUTIVE DIRECTOR shall lay before the meeting the report of the activities of the TRUST since the previous Annual General Meeting.

18. A circular resolution issued by the EXECUTIVE DIRECTOR in consultation with the CHAIRMAN/CHAIRPERSON on any subject and signed by the majority of the TRUSTEES, shall in all respects, be valid and binding as a resolution passed at a meeting of the Trustees of the Trustees dully convened and constituted and such resolution shall not be deemed invalid by reason of want of notice or any other cause whatsoever.

19. DECISIONS OF THE TRUSTEES

Except where otherwise otherwise provided any question arising as to the property or any transaction of the TRUST shall be conclusively settled as between all parties concerned by decision of majority of the number of TRUSTEES for the time being.

20. INDEMNITY

EVERY TRUSTEE shall be indemnified out of the TRUST FUND against all losses and expenses incurred in the discharge of his duties except such as shall happen through his own negligence willful act or default and each TRUSTEE shall be chargeable with only such money or property as he or they shall actually receive for or in the discharge affairs of the TRUST and each shall be answerable only for his own acts, neglects or defaults and not for those for any other person.

22. VARIATION OF THE TERMS OF TRUST

ALTERATIONS to the clauses of the Deed shall only be made at meeting of the TRUSTEES after giving notice of TWO calendar months which notice shall be accompanied by details of the proposed alterations and shall be subject to confirmation at a Second meeting of the Trustees held not earlier than one Calendar month after the First Meeting. Clauses may be altered by the votes of Two-thirds of the number of the TRUSTEES with the prior permission of Commissioner of Income-tax. All alterations shall be confirmed by a DEED





23. DISSOLUTION AND DISTRIBUTION OF ASSETS


If at any time the continuation of the trust shall appear to two-thirds the TRUSTEES for the time being not to serve any useful purpose the TRUST shall forthwith be wound up and any assets remaining after the satisfaction of all lawful liabilities and claims against the TRUST the same shall under no circumstances be paid to or distributed among the TRUSTEES, for the time being or former TRUSTEES or made available for personal benefit of anyone but shall be given to some other registered Society, Trust, Association or Institution to be determined by two-thirds of the TRUSTEES for the time being and which enjoys recognition under Section 80G of the Income Tax Act, 1961, amended from time to time or in default thereof by the court of law having jurisdiction in the matter.


